

GREY MARKET

A grey market is an unofficial market for financial securities.

Grey market trading generally occurs when new securities are bought and sold before official trading begins.

The gray market enables the issuer and underwriters to gauge demand for a new offering. Grey market prices are determined by demand and supply.

Many investors and brokers look at it as a rough indicator of the post listing performance of the stock.
